# LABOUR & SOCIAL LAW

The LCGB is your first contact point for all questions related to labour and social law. The LCGB offers free help, assistance and consultations in various languages with regards to the health and maternity insurance, unemployment and occupational reclassifications, family benefits, pensions and disability insurances, accident insurances as well as social insurance.

### Free legal assistance

- » For labour or social law litigation
- » Within the specified limits (the code of instructions can be consulted via www.lcgb.lu)
- » No initial membership duration required
- » Required to keep the LCGB affiliation for the duration of the entire procedure as well as the following 24 months
- » A resignation within this timeframe requires the member to reimburse all legal fees

### PROFESSIONAL HELP FOR PRIVATE LIFE PROCEDURES

The LCGB offers professional help in various languages for all private life procedures or in dealing with government agencies such as the renewal of the driver's license or the passport, questions related to excessive indebtedness or general questions related to customs (i.e. vehicle registration).



### Tax return

The LCGB offers help and assistance in filling out your tax return.



### **Pensions**

The LCGB offers you an analysis of the professional career for creating a simulation and estimation of the pension. The LCGB offers free help with the procedures to follow when transitioning from work life to retirement.



# Legal assistance for private issues

The LCGB offers help and assistance in case of a divorce, guardianship or in case of questions or issues related to tenancy agreements (i.e. dissolving of the tenancy contract, auxiliary costs, etc.) whilst covering parts of the legal fees.
