## LABOUR & SOCIAL LAW

The LCGB is your first contact point for all questions related to labour and social law. The LCGB offers free help, assistance and consultations in various languages with regards to the health and maternity insurance, unemployment and occupational reclassifications, family benefits, pensions and disability insurances, accident insurances as well as social insurance.

### Free legal assistance

- » For labour or social law litigation
- » Within the specified limits (the code of instructions can be consulted via [www.lcgb.lu](http://www.lcgb.lu))
- » No initial membership duration required
- » Required to keep the LCGB affiliation for the duration of the entire procedure as well as the following 24 months
- » A resignation within this timeframe requires the member to reimburse all legal fees



# COMPLEMENTARY PROFESSIONAL PROTECTIONS

In order to benefit from one of the complementary legal protections, you must be affiliated to the LCGB by paying the full membership dues of 22 € per month. You can download the necessary forms via [www.lcgb.lu](http://www.lcgb.lu).



## **Legal assistance** Professional drivers or employees driving as part of their professional activities

Compensation claims based on the legal provisions of the civil liability. Legal assistance and defence in case of a traffic code violation or a legal regulation infringement. In case of imprisonment, requests for appeals or parole are included; max. 2 requests per claim. Legal assistance in case of criminal or administrative proceedings following the prohibition, withdrawal, restriction or renewal of the driver's license.



## **Legal assistance** Employees with bargeman patents

Compensation claims based on the legal provisions of the civil liability. Legal assistance and defence in case of a violation of the legal regulations of the river navigation. In case of imprisonment, requests for appeals or parole are included; max. 2 requests per claim. Legal assistance in case of criminal or administrative proceedings following the prohibition, withdrawal, restriction or renewal of the bargeman patents.



## **Professional civil liability and legal assistance** Health professionals

Valid for health professionals in Luxembourg, which hold the required degrees and, if applicable, the necessary authorisations to practice their profession in Luxembourg. Professional civil liability (non-cumulative with the private civil liability). Legal assistance in case of criminal charges, such as legal counsel fees, judicial fees as well as all fees related to an objection, appeal or revision (cumulative with the private civil liability).



## **Legal assistance** Security agent

This legal assistance applies to professionals of the security sector within the borders of Luxembourg for public or private property surveillance activities/missions.

# HELP FOR PRIVATE LIFE PROCEDURES

The LCGB offers professional help in various languages for all private life procedures or in dealing with government agencies such as the renewal of the driver's license or the passport, questions related to excessive indebtedness or general questions related to customs (i.e. vehicle registration).



## Pensions

The LCGB offers you an analysis of the professional career for creating a simulation and estimation of the pension. The LCGB offers free help with the procedures to follow when transitioning from work life to retirement.



## Legal assistance for private issues

### Balancing your energies

Enabling participants to become aware of the way they function, their potential but also their limits, stress factors and responses to stress. Analyse your energy sources as well as consumers and through exercises and tools find the best means to bring them into balance in order to avoid situations of emotional distress, exhaustion or burn-out.



### Contract Negotiation

This workshop draws attention to the different types of salaries and non-statutory benefits and sensitises participants to effective negotiation techniques with an employer. A contract negotiation must take into account multiple factors that need to be analysed and prioritised. Practical exercises and answering questions will be provided.



### Self-confidence

This workshop will discuss the theoretical concepts of self-confidence and self-esteem. You will learn to understand how to protect yourself from situations that can have a negative impact on your self-esteem and how to identify activities that can help you build it.
